Re: Report on the Allegation that San Jose City Officials, the U.S. District Court in San Jose, and the Ninth Circuit Court of Appeals Obstructed Justice during Litigation of the Case Bates v. City of San Jose et. al. in order to Cover up Discrimination and Racism by the City of San Jose

Dear Minority Leader Jeffries:

Enclosed is a report on flash drive documenting my allegation that the above officials obstructed justice during litigation of a lawsuit I filed in 2006 against the City of San Jose for racial and disability discrimination upon my medical disability retirement from the San Jose Police Department as a police sergeant. I am black/African American.

The report presents indisputable evidence that the discriminatory conduct of San Jose city officials was malicious, retaliatory, and was done with the specific intent to cause me severe emotional pain and suffering, and financial loss because of my disability and race. The report presents evidence that San Jose city officials knowingly and intentionally violated California law and City policy that guaranteed me the rights to due process.

During litigation of my lawsuit, the report makes it clear that San Jose city officials knowingly perpetrated fraud on the U.S. District Court in San Jose and the Ninth Circuit Court of Appeals. It is also clear from the report that my attorney and judges in the U.S. District Court in San Jose were complicit in the City's fraud, and that City officials and officials with the District Court committed several felonies relating to public corruption that includes, conspiracy to obstruct justice, obstruction of justice, subornation of perjury, perjury, creating fraudulent docket entries, and conducting a fraudulent hearing on a motion for relief I filed. It is also unmistakable from the report that the rulings of the District Court and the Ninth Circuit Court of Appeals are flagrantly biased in favor of the City of San Jose and are in violation of the neutrality requirement of the Fifth Amendment Due Process Clause.

I am aware that the claims in my report against San Jose city officials and court officials are very serious. But I'm confident that my claims are supported by facts and evidence. I also understand that our system of government provides for an independent judiciary, a necessary component of the checks and balances between our co-equal branches of government. However, the independence of our judiciary does not give judges the authority to make rulings that are

intentionally erroneous and inconsistent with the clearly established facts and laws. The report presents indisputable and overwhelming evidence that each of the rulings in my lawsuit were made by judges with the knowledge they were biased against me, and are clearly erroneous. The report makes this as clear as day. I respectfully request that you use your leadership position in Congress to ensure that an investigation is initiated into this matter. Please be aware that I am filing an ethics complaint against Congressman Sam Liccardo for his role in this scheme to obstruct justice as a councilmember, and as mayor of the City of San Jose. Please be advised that I am also making complaints regarding this matter with other Members of Congress, the Supreme Court and the Department of Justice.
