Re: Report on the Allegation that San Jose City Officials, the U.S. District Court in San Jose, and the Ninth Circuit Court of Appeals Obstructed Justice during Litigation of the Case Bates v. City of San Jose et. al. in order to Cover up Discrimination and Racism by the City of San Jose

Dear Senator Grassley:

Enclosed is a report on flash drive documenting my allegation that the City of San Jose, the U.S. District Court in San Jose, and the Ninth Circuit Court of Appeals obstructed justice during litigation of a lawsuit I filed against the City in August 2006. My lawsuit sought damages from the City for its discriminatory and racist violation of my rights upon my medical disability retirement from the San Jose Police Department as a police sergeant. I am black/African American.

The report presents facts and evidence that San Jose city officials concocted an elaborate scheme to perpetrate fraud on the U.S. District Court in San Jose, and the Ninth Circuit Court of Appeals in a motion for summary judgment in order to cover up its discriminatory and racist conduct. It is clear from the report that judges in the U.S. District Court in San Jose and the Ninth Circuit Court of Appeals committed impeachable offenses by participating in the City of San Jose's fraudulent scheme based on their conduct and rulings that showed flagrant bias in favor of the City, a willful and wanton disregard for the facts, and contempt for the Constitution and applicable laws. The actions of these judges, who are named in the report, demonstrates a lack of judicial temperament because they failed to uphold the integrity and independence of the judiciary; they failed to avoid impropriety and the appearance of impropriety, and they failed to perform their duties fairly and impartially. Their abuse of power and corruption in this case undermines the public's confidence in the judiciary, and is a threat to democracy.

In the appendix of my report is a copy of a petition for a writ of certiorari that I filed in the Supreme Court seeking relief from the fraudulent judgment in my lawsuit. My petition was denied on October 2, 2023, despite the fact that the judgment of the lower court is clearly erroneous; it is based on fraud, a violation of the law, and bias.

I respectfully request that the Senate Judiciary Committee conduct an investigation into my allegation based on the enclosed report. Please take note that the misconduct I allege, with

supporting evidence, is that San Jose city officials and officials with the U.S. District Court in San Jose committed several felonies relating to public corruption. You should be aware that my previous attempts to open investigations into this matter with the House and Senate Judiciary Committees, as well as, individual Members of Congress were unsuccessful. I also made complaints with Chief Justice John Roberts, the Attorney General's Office, and the Federal Bureau of Investigation that failed to produce any investigations. Additional information, including my manifesto, is included on the flash drive with my report that support my claims.

Please be aware that I am filing an ethics complaint against Congressman Sam Liccardo for his role in this scheme to obstruct justice as a councilmember, and as mayor of the City of San Jose. I am also making complaints regarding this matter with other Members of Congress, the Supreme Court and the Department of Justice.
